Tate & Lyle <u>announced an agreement</u> in July to separate our food & beverage solutions business (remains with Tate & Lyle) and primary products business (becomes the new company Primient). The separation will create two stronger businesses, requiring new accounts for new legal entities.

We will provide instructions closer to the February 1 date.
