This email is a **reminder to update your account information** in preparation for our January 28, 2022, separation. Please prepare now to make the necessary changes in your system.

Account changes will be necessary because of Tate & Lyle's [agreement announced in July](#) to separate our **Food & Beverage Solutions** business and **Primary Products** business to create two stronger businesses. The two new business accounts are shown in green below.
